- Job Description: ICPR will supply a hard copy of the book to be re-printed, along with work order. The printer is to perform high resolution scanning of the entire book, process the scanned images to make it ready for printing and then print and supply 300 copies of the book. Number of copies of each book to be reprinted = 300
- Paper - text on 90 GSM Star natural shade maplitho paper, Cover hard bound
- Works is to be completed within 30 days from the order for printing.
- Rate quoted shall be valid for 60 days.
- In the financial Bid, rate shall be quoted separately for each book. The financial bid include rate for the book, GST and total amount.
- Pick up of the books and supply of the printed books shall be at ICPR office address and no additional cartage charge shall be payable.
- Payment shall be made after satisfactory works of printing as per specification through bank transfer within 30 days after the submission of the bill.
- ICPR keeps the right reserved for printing or not printing any of the book/ books.
- Both technical and financial bids must be submitted. **The Technical Bid and Financial Bid should be sealed by the bidder in separate covers duly superscribed and both the sealed covers are to be put in a bigger cover which should also be duly sealed.** The financial bids of only those bidders shall be opened who qualify the technical bids.
- The technical bid should contain:
 - a) Company profile
 - b) Registration profile
 - c) PAN/ ITR/ GST
 - d) Order copies of past similar jobs from Govt./ PSU/ Autonomous Organisations
 - e) Acceptance of all terms and conditions
 - f) Printer of repute with in-house facilities and minimum 5 years of experience in the field of printing of books will be given preference
 - g) The bidders have to sign and deposit a 'bid-security Declaration' accepting that if they withdraw or modify their bids during three months after the last date for the submission of the tender, they will be suspended for a period of one year.

- The successful tenderer will have to submit Performance Bank Security equivalent to 3% of the value of the total order value amount. The amount will be payable through Bank Draft/ Chaque drawn in favour of 'Indian Council of Philosophical Research'. In case of breach of any terms and conditions. The Performance Security Deposit of the printer will be liable to be forfeited by the Council.
