उद्घोषणा

भारतीय दार्शनिक अनुसंधान परिषद् भारत के विभिन्न महाविद्यालयों, जहां दर्शनशास्त्र पढ़ाया जाता है, छात्रों, विद्वानों और शिक्षकों को लाभान्वित करने के लिए हर वर्ष प्रतिष्ठित विशेषज्ञों द्वारा आवधिक व्याख्यान आयोजित करने हेतु अनुदान प्रदान करता है। ऐसे महाविद्यालय वरिष्ठ/प्रतिष्ठित विद्वानों को आमंत्रित कर, नीचे दिए गए विषय के अनुसार दर्शन एवं अन्य संबंधित क्षेत्रों में प्रति विद्वान एक या दो व्याख्यान (कुल 4 व्याख्यान) करा सकते हैं :

व्याख्यान कार्यक्रम आयोजित करने हेतु निम्नलिखित विषयों में से किसी एक का चयन किया जा सकता है।

- सत्य और ज्ञान का सिद्धांत
- भारतीय संस्कृति में निहित मौलिक मूल्य तथा राष्ट्रीय पुनर्निर्माण में उनकी प्रासंगिकता
- समकालीन विचारकों का दार्शनिक योगदान.
- दर्शन, प्रौद्योगिकी और विज्ञान
- मानव का दर्शन और पर्यावरण
- समाज और राजनीतिक दर्शन
- दार्शनिक प्रणालियों/आंदोलनों और धर्मों का तुलनात्मक और समालोचनात्मक अध्ययन
- तर्क, गणित दर्शन और भाषा का दर्शन
- वैश्वीकरण की नैतिकता
- क्रीड़ा नैतिकता
- स्वान्त्योत्तर भारतीय दर्शन
- आलोचनात्मक चिंतन और दर्शन

परिषद् चयनित महाविद्यालयों को 30,000.00 रु० की राशि स्वीकृति करेगी। यह निधि केवल प्रधानाचार्य के नाम जारी होगी। प्रति व्याख्यान/विशेषज्ञ मानदेय 3,000.00 रुपये से अधिक नहीं होना चाहिये तथा बैनर, प्रमाण पत्र, पोस्टर इत्यादि के लिए आकस्मिक व्यय राशि 5,000.00 रु० से अधिक नहीं होनी चाहिये।

इस कार्यक्रम की योजना इस तरह बनाई जाए कि अनुदान प्राप्त होने की तिथि से 31 जनवरी 2024 के बीच आयोजित किया जा सके। लेखा की सूची/मूल बिल/वाऊचर, व्याख्यानों की प्रतियां/फोटो और कार्यक्रम की रिपोर्ट कार्यक्रम की समाप्ति के एक महीने के भीतर हार्ड एवं सॉफ्ट कॉपी दोनों परिषद् को भेजी जानी चाहिए।

Announcement

Indian Council of Philosophical Research (ICPR) has an ongoing scheme of supporting the different colleges in Indian where Philosophy is taught for Periodical Lecture, every year to enable students, scholars and teachers of philosophy to be benefit by lectures of eminent scholars. These colleges may invite senior/eminent scholar who can deliver one or two lectures (total 4 lectures) in philosophy.

To commemorate and celebrate the event, one of the following themes may be selected.

- Theories of Truth and Knowledge.
- Basic Values Embodied in Indian Culture and their Relevance to National Reconstruction.
- Philosophical Contribution of Contemporary Thinkers.
- Philosophy, Science and Technology.
- Philosophy of Man and Environment.
- Social and Political Philosophy.
- Comparative and Critical Study of the Philosophical Systems/Movements and Religions.
- Logic, Philosophy of Mathematics and Philosophy of Language.
- Ethics of Globalization.
- Sports Ethics.
- Post-Independence Indian Philosophy.
- Critical Thinking and Philosophizing.

The application should be routed through the Principal/Director/ Registrar/Dean of the Institute. The sanctioned amount shall be released through the Principal/Director/ Registrar/Dean.

The selected department will be provided a grant up to Rs. 30,000/- (thirty thousand only) for conducting this event. The faculty and students of neighboring universities and institutions may be invited without exceeding the budget of ICPR. Additional budget, if required may be arranged from the host institute or other sources. Honorarium per Lecture/Resource Person is Rs. 3,000/- plus incidental expenses not more than Rs. 5,000/- for preparation of programme banners, certificate, poster etc.

The programme should be planned in such a way that it can be organized between 31st January, 2024 from the date of receipt of grant. Academic Report with photographs in MS Word, Statement of account and original bills/vouchers, Script of Lectures of the programme should be submitted to the Council within one month after completion of the programme in hard copy and soft copy both.
