Academic Centre of Indian Council of Philosophical Research (ICPR), 3/9, Vipul Khand, Gomti Nagar, Lucknow – 226010, an organization under the MHRD, Government of India, hereby invites quotations for Non-Comprehensive AMC for **Pest-Control** for Academic Centre, ICPR, Lucknow for the **Year 2017-18 on Quarterly** basis to meet its pest control requirements, on the following terms and conditions. There is no prescribed format for the quotations, but the quotation must bear the name and signature of the concerned authority, name of the firm, with valid registration no, type of service, mode of service.(Format attached for example)

The Office requires pest-control-service covering three floors including Offices on Ground Floor, Library Stack Area on First Floor, Conference Hall on Second Floor & other covered areas. The quotations be submitted / sent to us, preferably in letter head of the companies / service providers, along with required certificates validating their service, and documents exemplifying that the party has similar experience of providing pest control services in other offices, if any. The party should clearly mention the rate(s) of each pest-control-service, which will be valid and **unchangeable** for at least one year w.e.f. the award of the order. The GST/taxes should be mentioned as per Govt. norms, which may be **changeable** as per rules of the Govt.

Terms and conditions:-

1. The pest-control-service should be provided inside the office building 3/9, Vipul Khand, Gomti Nagar, Lucknow-226010.
2. Pest-control-service should be done quarterly (every 3months) / as per requirement, at the mentioned rates. Punctuality is a must.
3. Payment will be made on quarterly basis on production of the bills & satisfactory report with applicable TDS through ECS. For this a filled-in ECS form will be submitted after award of the contract.
4. The service-provider must certify that the Pesticides they use are **safe for Human-Interaction**. The service should be prompt and the quality of pesticides must be up to the mark and **safe for Human-Interaction**. Otherwise, the order will be terminated at any time, if awarded.
5. At the time of charging service and furnishing bills, the registration no. of the supplier must be recorded in the bill. The firm must be registered under Govt., agencies/organization as required, and have all permission and legal certification for the service and supply.
6. The decision of ICPR will be final. The office reserves the right to accept or reject any/all the quotations without assigning any reason thereof.
7. All legal matters, if any, will be taken under the jurisdiction of the concerned authority at Lucknow or Delhi only.
