**NOTICE INVITING QUOTATIONS FOR REPAIRING OF ROOFTOP BOUNDARY WALL
/PARAPET WALL WITH TILING**

Indian Council of Philosophical Research is an Autonomous Body fully funded by the Ministry of Education, Government of India.

Quotation are invited for the above repairing work in a sealed envelope in below-

The technical and financial bids should be sealed by the bidder in separate envelope duly super-scribed and both the sealed envelopes are to be put in a bigger envelope which should also be sealed and duly super-scribed. Commercial bids of only technically qualified bidder will be considered. Bidder are required to submit "Bid Security Declaration" as per latest O.M. No. F.9/4/2020-PPD, dated 12.11.2020 issued by Ministry of Finance, Department of Expenditure, Procurement Policy Division, Government of India.

Quotation are invited for the above repairing work in a sealed envelope by 1730 hours on 28.06.2021 and may be forwarded to the Director (A&F), Indian Council of Philosophical Research, Darshan Bhawan, 36 Tughlakabad Institutional Area, Near Batra Hospital, M.B. Road, New Delhi-110062 by Registered port or deposit by hand in tender box placed a Security guard room at ICPR, New Delhi. The advertisement in this regard has also been published in the website of the Council www.icpr.in.

The Technical Bid contain acceptance to following:

- a) Scope of Work is subject to upto 5% increase without any additional cost. Pro-rata payment shall be made for any increase in scope of work after approval of the Competent Authority of ICPR. The temporary structure, if any installed/erected on wall, must be dismantled and removed. Dismantling old plaster or skirting raking out joints and preparing the surface for plaster. Injecting approved grout in proportion recommended by the manufacturer into cracks/honey-comb area of concrete/masonry by suitable gun/pump at required pressure and cutting of nipples after curing. Re-plaster the surface of thickness 14±2mm in patches and repaint.
- b) Total Boundary Wall Area : 880 Sq.ft. Approx.
- c) Material Specifications : Re-Tiling (Granite) & Re-Plaster (1:4 Cement & sand)
- d) Removal of existing tiles & plaster.

The following documents should be enclosed with technical bid:

- a) Commercial bid with unit rates eg. per sq. ft., per meter, per nos. etc. clearly indicating taxes with acceptance of terms and conditions of tender.
 - b) Company profile and registration details with copy of relevant documents.
 - c) Copy of Income Tax Return and Pan Card.
 - d) Past order copies for similar work for any Govt. organization, references etc.
 - e) Providing and fixing of power outlet with electrical wire and condute pipe, connection tapping from nearest point including switch socket and phase plate and base box etc.
 - f) Providing and fixing of outdoor balkhed LED light fixture.
- A pre bid meeting will be held on 22.06.2021 at 1200 hours. Interested bidders for having a pre-bid meeting may contact this office for further details and may visit during working hours for physical inspection before bidding.
 - Certificate from independent engineer/architect will be required for work completion in all aspects.

Performance Bank Guarantee (PBG):

The concerned firm will be required to submit a PBG for a value of 3% of order value on receipt of confirmed order as per the latest O.M. No. F.9/4/2020-PPD dated 12.11.2020 issued by Ministry of Finance, Department of Expenditure, Procurement Policy Division, Government of India, Delhi.

Technical bids shall be opened at 1200 hours on 29.06.2021 at ICPR Office. Interested bidder may attend the bid opening process. The commercial bids of only successful bidder shall be opened at a subsequent date and time. The decision of the Competent Authority, ICPR shall be binding and final. Disputes, if any, shall be subject to jurisdiction of Delhi High Court only.
