Indian Council of Philosophical Research (ICPR) has an ongoing scheme of helping the Colleges in India where Philosophy is taught for organizing Periodic Lectures every year to enable students, scholars and teachers of Philosophy to be benefited by lectures of eminent scholars. These colleges may choose senior eminent scholar who can deliver one or two lectures in philosophy and other related areas as per theme below:

- Theories of Truth and Knowledge.
- Basic Values Embodied in Indian Culture and their Relevance to National Reconstruction.
- Philosophy, Science and Technology.
- Philosophy of Man and Environment.
- Social and Political Philosophy.
- Comparative and Critical Study of the Philosophical Systems/Movements and Religions.
- Logic, Philosophy of Mathematics and Philosophy of Language.
- Ethics of Globalization.
- Sports Ethics.
- Post Independence Indian Philosophy.
- Critical Thinking and Philosophizing.

The Council will sanction a sum of **Rs. 20,000**/- to each of the selected Colleges. The grant shall be released only to the Principal. No individual application will be entertained by the Council.

ICPR will select 50 such colleges around the country from the applications received. Each selected college will be sanctioned **Rs. 20,000/-** for the programme. Interested Departments of colleges may kindly submit their applications in the prescribed form with Bank Authorization Form (available in the Website of ICPR, Download Section) by September 13, 2019.

The programme should be planned in such a way that it should be conducted between the date of grant received to **31st March**, **2020**. Statement of account and original bills/vouchers, Script of Lectures, Photographs and Report (a copy via email to <a href="mailto:seminar.icpr@gmail.com">seminar.icpr@gmail.com</a>) of the programme are to be submitted to the Council within one month after the completion of the programme. The Council has reserved rights to select/reject any application as deemed fit.
