भारतीय दार्शनिक अनुसंधान परिषद विश्व दर्शन दिवस के उपलक्ष्य में कार्यक्रम आयोजन हेतु अनुदान प्रदान करता है । विश्व दर्शन दिवस, जो यूनेस्को की घोषणा के अनुसार सामान्यतः प्रतिवर्ष नवम्बर के तीसरे बृहस्पतिवार को पड़ता है इसे क्षेत्रीय/स्थानीय स्तर पर दर्शन से संबंधित संगोष्ठी/एक दिवसीय सम्मेलन/संवाद/कार्यशाला जैसी शैक्षिक गतिविधियां करके मनाने के लिए परिषद् विश्वविद्यालय के विभागों और अन्य शैक्षिक संस्थानों/संगठनों से आवेदन आमंत्रित करती है । यह आवेदन संस्था के निदेशक/डीन/रिजस्टार के माध्यम से भेजे जाने चाहिए । स्वीकृत राशि, निदेशक/डीन/ रिजस्टार के माध्यम से नारी की जाएगी । परिषद किसी व्यक्ति–विशेष का आवेदन स्वीकार नहीं करेगी ।

Indian Council of Philosophical Research (ICPR) has been supporting celebration of World Philosophy Day, which, as declared by UNESCO, has been usually observed on third Thursday of November of the year. For this, the Council invites applications from the Departments of University or such Educational Institutes/Organizations to hold some academic events, like Seminars/Workshops/Colloquiums/One-day Meet etc., in Philosophy at the Regional/ Local Level. The application should be routed through the Registrar/Dean/Director of the Institute. The sanctioned amount shall be released through the Registrar/Dean/Director. No individual application will be entertained by the Council.

To commemorate and celebrate the event, one of the following themes may be selected.

- Theories of Truth and Knowledge.
- Basic Values Embodied in Indian Culture and their Relevance to National Reconstruction.
- Philosophy, Science and Technology.
- Philosophy of Man and Environment.
- Social and Political Philosophy.
- Comparative and Critical Study of the Philosophical Systems/Movements and Religions.
- Logic, Philosophy of Mathematics and Philosophy of Language.
- Ethics of Globalization.
- Sports Ethics.
- Post Independence Indian Philosophy.
- Critical Thinking and Philosophizing.

The selected Universities will be provided a grant up to **Rs. 30,000**/- for conducting this event. The faculty and students of neighbouring universities and institutions may be invited without exceeding the budget of ICPR. Additional budget, if required may be arranged from the host institute or other sources.

Statement of account of the entire expenditure supported by Original Bills/Vouchers, Script of papers, Photographs and Report on the programme are to be submitted to the Council within one month of the completion of the programme to seminar.icpr@gmail.com for uploading on ICPR Website.

The Council reserves the rights to Select/Reject any application as deemed fit.

Applications in the prescribed format and Bank Authorization Form is available in the Website of ICPR, New Delhi (<u>www.icpr.in</u>) may be submitted to the Council **by September 13, 2019.** Preference will be given to those who have not availed this grant during the last three years.
